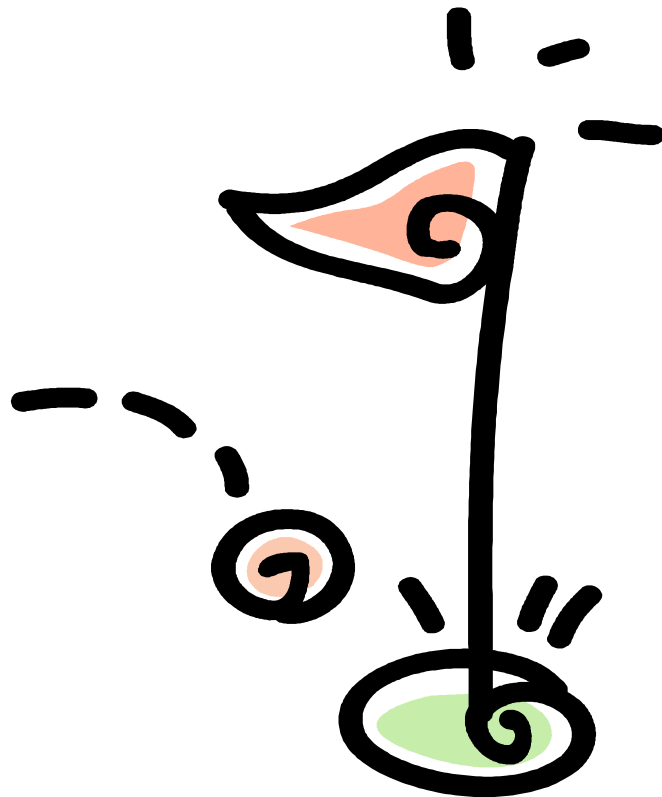




# 2019 Junior Golf Informational Packet



Greensburg Country Club's Junior Golf Program is open to children ages seven through eighteen whose parents or grandparents have a GCC membership. The cost is \$100.00 per child for children and grandchildren of **GOLF** members. The cost is \$300.00 per first child for **children and grandchildren of non-golf members** (Athletic, Community and Pool) and \$100.00 for each additional child. Community and pool juniors are permitted to golf on Junior Golf days **ONLY**. Juniors who are grandchildren of golf members are permitted to play golf on other days only if accompanied by grandparent.

If paying by check, please make payable to GCC JUNIOR GOLF. You may also have the Junior Golf fee charged to your house account.

Junior Golf Play Days will begin with a warm-up period on the driving range and/or practice green followed by tee times:

**18 Holers** – Junior golfers who have completed at least four 9-hole rounds with scores below **50** during regular junior golf play.

**9 Holers** – Junior golfers who have completed at least four 7-hole rounds with scores below **40** (from the Yellow Junior tees) during regular junior golf play. Junior must also be able to break 70 for 9 holes from the Red tee markers.

**7 Holers** – Junior golfers who have completed at least four 4-hole rounds with scores below **24** (from the Green Junior tees) during regular junior golf play.

**4 Holers** – Junior golfers who have completed an evaluation with the Professional Staff and are able to walk and carry their bag for 4-holes.

\*Eighteen holers will play 18-holes for organized junior golf scoring. This is a change from previous years, and is intended to increase the competition among the older players.

**ALL JUNIORS ARE REQUIRED TO WALK, CARRY THEIR OWN CLUBS, AND HAVE THEIR OWN EQUIPMENT. Four holers are permitted to ride between holes only. Adults are NOT to carry juniors' clubs.**

Proper attire is mandatory on Junior Golf Play Day and for all visits to the golf course and driving range. Jeans and t-shirts are not appropriate.

An adult is required to accompany all groups of four and seven holers.

*Parents are asked to volunteer to accompany a group as their schedule allows. This is not a requirement of your child's participation, but a request for assistance from the Professional Staff. – Thank you!*

**All juniors and their parents are encouraged to attend the 2019 Junior Golf Orientation meeting on Sunday, May 5, at 3:00 pm in the GCC Clubhouse. We will be reviewing the Junior Golf schedule, speaking about the Rules of Golf changes, course etiquette, and giving out rule books.**

**The Practice Day will again be a part of the Junior Program this season. The Professional Staff will offer 45 minute clinics covering Putting, Chipping, Pitching, Bunker Play, and Full Swing with Irons and Woods. These clinics will be structured to introduce new short game and full swing concepts in a fun, relaxed atmosphere where the juniors can learn at their own pace.**

  - \* If a child is not in the Junior Golf Program, without regard to age, the child will have 4/7 holer playing privileges unless he/she has been evaluated by the Professional Staff.
  - \* Four and seven holers must be accompanied by a parent/adult at ALL times, including on the range.
  - \* Juniors are only permitted to use range from DESIGNATED junior area.

**RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK & INDEMNIFICATION**

IN CONSIDERATION of being permitted and/or my minor child (“Junior Golfer”) being permitted to participate in the Greensburg Country Club Junior Golf Program and its associated activities (“Activities”), I, for myself, my personal representatives, heirs and assigns hereby agree as follows:

I warrant that I am the parent, legal guardian or custodian of the child (“Junior Golfer”) identified below. I understand and agree to this Release and Waiver and agree to be bound by its terms, for myself and on behalf my Junior Golfer, and our heirs and assigns.

I, on behalf of myself and my Junior Golfer, affirm that I understand the nature of golfing activities and my Junior Golfer’s experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby covenant not to sue Leghorn Golf Group, LLC; Greens, Kegs and Ham, Inc.; and Greensburg Country Club, as well as their respective owners, administrators, agents, officers, members, volunteers, employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activities take place, (each together and separately “GCC”) and hereby release and discharge GCC from all liability, claims, demands, losses, or damages on my account or on the account of my Junior Golfer caused or alleged to be caused in whole or in part by the negligence of GCC or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, my Junior Golfer, or anyone on my, or my Junior Golfer’s, behalf, makes a claim against GCC, I will indemnify, save, and hold harmless GCC from any litigation expenses, attorney fees, loss, liability, damage, or cost incurred as the result of such claim.

I fully understand that (a) golfing activities involve risk and dangers of serious bodily injury, including permanent disability, paralysis and death (“Risk”); (b) these Risks and dangers may be caused by my, or my Junior Golfer’s, own actions, or inactions, the actions or inactions of others participating in the Activities, the condition in which the Activities take place, or the negligence of GCC; (c) there may be other risks, social and/or economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost and damages I incur or that my Junior Golfer incurs as result of participation in the Activity.

I understand that GCC reserves the right to film, photograph and/or videotape facilities, activities, and Junior Golfers for potential future use. I further understand that these items will remain the property of GCC and may be used by GCC for publicity or promotional purposes.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
